- 6.1. Consideration and possible action to complete and return ballot for LAFCO Special District Representative. (President Hardenbrook)

 After brief discussion of candidates' qualifications, it was moved by Director Perez to direct President Hardenbrook to cast ballot for Vanessa Montemayer of Buttonwillow County Water District. Motion approved by unanimous consent.
- 6.2. Consideration and possible action to adopt policies, rules, regulations, and ordinances. (President Hardenbrook)
 No action taken.
- 6.3. Consideration and possible action to retain services of a real property appraiser. (President Hardenbrook)

 President Hardenbrook provided Board with a proposal from Eric Anderson, a commercial property appraiser, to provide appraisal services for certain subject properties. Director Romo moved to direct President Hardenbrook to accept proposal and have properties appraised.. Motion approved by unanimous consent.
- 6.4. Consideration and possible action to request proposals for water rate study. (President Hardenbrook)

 President Hardenbrook briefed Board on need to provide a rate study to enable setting of sustainable service fees and that the proposed Prop. 84 budget includes funding for a rate study but that performing rate study as soon as possible will allow setting rates sooner and provide evidence for Water Boards Prop. 84 review of District's ability to financially operate system. Director Perez moved to direct President Hardenbrook to seek proposals for conducting a rate study. Motion approved by unanimous consent.
- 6.5. Consideration and possible action to hold "Town-Hall" meeting with area residents to determine unmet water service's needs. (Director Hardenbrook)

 President Hardenbrook suggested the District hold a "town hall" I type meeting for the residents of the Pine Canyon Area and any other residents concerned with the availability of water service. President Hardenbrook further suggested this would allow the District to determine area residents needs, identify possible new service connections and determine possible grant opportunities to extend service beyond current coverage area. Director Romo moved to approve holding a "town hall" style meeting. Motion approved with 2 ayes (Director Hardenbrook and Director Romo) 1 no (Director Perez) and 2 absent (Director Rezac and Director Casteel).

6.6. Consideration and possible action to provide water service to lots within tract 3312. (Director Hardenbrook)

President Hardenbrook informed the Board that a property owner in Tract 3312 has requested service from the District and that the property owner has a previously issued will-serve letter from the District. Currently the District does not have facilities in the vicinity of the subject property and there is some concern as to feasibility of providing service at this time. President Hardenbrook suggested that Board seek advice of counsel specializing in water law related matters prior to making any decision regarding service to subject property. President Hardenbrook moved to table item to next meeting to allow him time to solicit proposals from attorneys specializing in water related matters. Motion approved by unanimous consent.

 President Hardenbrook reported to Board that he and Secretary Cantrell attended a no-charge training session held by Cal Rural water in Bakersfield to explain and demonstrate use of an EPA tool for determining management priorities.
