  General Manager presented information to Board regarding proposed plans by Kern County to re-align and surface Umtali Road and the conflict between road work and existing QVWD water main. Director Casteel moved, seconded by Director Lopez, to direct General Manager to negotiate with Kern County for the relocation of water mains and due to time constraints imposed by Kern County, delegated authority to General Manager to accept terms and conditions most favorable to District in General Managers opinion. Motion approved by unanimous consent.
