MINUTES FOR THE REGULAR MEETING OF THE BOARD OF DIRECTORS OF QUAIL VALLEY WATER DISTRICT

Saturday, August 23, 2025, at 8:30 AM.

1. Roll Call.

*Meeting called to order at 8:31 AM. There were present, representing a quorum:
Director Biglay;
Director Lopez;
Director Shiells;
Director Sweany.
Director Tate joined meeting at 11:00.*

2. Adoption of Agenda.

Director Shiells moved, seconded by Director Sweany, to adopt agenda. Motion approved by unanimous assent.

3. Public comments for NON-agenda items.

Ryan Dalmas, a local accountant, was present and expressed an interest in performing audits for the District. General Manager Hardenbrook will further discuss with Mr. Dalmas.

4. Consent Calendar:

4.1. Approve Minutes from Regular Meeting of 05/31/2025.

*Director Shiells moved, seconded by Director Lopez, to approve consent calendar.
Motion approved by unanimous assent.*

5. Action Items:

5.1. Discussion of monthly financial statements and consideration and possible action to approve payments for May, June, and July, 2025. (General Manager Hardenbrook)

*General Manager Hardenbrook led a review and explanation of financial statements.
Director Shiells moved, seconded by Director Lopez, to approve payments for May, June, and July, 2025. Motion approved by unanimous assent.*

5.2. Discussion and possible action directing Secretary, with the assistance of Staff, to take actions necessary to hold General Election on November 4, 2025 for the purpose of electing two directors. (General Manager Hardenbrook)
No Declarations of Candidacy were received. Secretary has requested Board of Supervisors to make appointment of incumbents in lieu of an election. No action taken.

5.3. Discussion and possible action offering employee retirement plan. (General Manager Hardenbrook)
General Manager presented memo to Board explaining options to provide employees with a retirement plan. No action taken.

5.4. Discussion and possible action on COLA adjustment for 2026. (General Manager Hardenbrook)
General Manager presented a memo to Board explaining California minimum wage increase for 2026 and the impact on District pay scales. Director Biglay moved, seconded by Director Lopez, to approve an increase of 2.49% across all pay scales matching the California minimum wage increase for 2026. Motion approved by unanimous assent.

5.5. Discussion and possible action approving rate increase for 2026. (General Manager Hardenbrook)
General Manager presented a memo to Board explaining impact of cost increases to District finances and the need to increase water rates. Director Biglay moved, seconded by Director Lopez, to approve a 10% rate increase for 2026. Motion approved by unanimous assent.

5.6. Discussion and possible action to solicit proposals for FYE 2026 audit. (General Manager Hardenbrook)
General Manager presented a memo to Board explaining need to solicit proposals for performance of biennial audit. No action taken.

5.7. Discussion and possible action to replace Office computers not compatible with Windows 11. (General Manager Hardenbrook)
General Manager presented a memo to Board explaining Windows 10 end of life and impact on District computers. Director Biglay moved, seconded by Director Tate, to replace 1 office computer not compatible with Windows 11 at this time and enroll in Extended Service for remaining non-compatible computers. Motion approved by unanimous assent.

General Manager presented a memo to Board explaining proposed budget and assumptions used in preparation of budget. Director Sheills moved, seconded by Director Lopez, approving budget for fiscal year 2025 – 2026. Motion approved unanimous assent.

FINANCIAL REPORT SUMMARY

October 2025


- Current (Oct 22, 2025) cash (Petty Cash, Kern County, Checking Accounts, Payroll Account) on hand: \$22,692.
- Accounts Receivable as of Oct 22: \$127,478. Balance includes approximately \$4,000 in arrears over 1 year that are likely not recoverable and need to be charged off along with approximately \$6,000 in arrears on disconnected accounts that won't be recovered until property is reconnected.
- Total current liabilities (10/22/25): \$80,197.
- Voluntary Rate Increase balance: \$803.89, down from peak of \$21,860 in December of 2019.
- Upcoming Significant Expenses:
 - Sand Canyon Well: Title 22 sampling approximately \$3,000.

Notes to below charts:


P&L Cash large increase in cash for January/February attributable to Property Taxes credited to Kern County tax account. A second increase should have occurred in April/May but tax information still not available from Kern County due to their accounting system changover.

P&L (Accrual) large increase in Income for April attributable to Property Taxes received, large increase in Expense for June attributable to recordation of annual depreciation expense.


A/P & A/R large increase in A/P for May attributable to RCAC loan to pay CoBank Prop 84 LOC.

There are no account registers available for Valley Strong Savings or Kern County accounts as no activity has been recorded for the 1st quarter. Kern County still does not have any information available for tax transaction activity for this fiscal year and very limited information is available for 4th quarter of last year. Historically District would expect receiving about \$5,000 in tax collections in 1st quarter and considerably more (about \$20,000) in 2nd quarter.

Patriot payroll account indicates normal activity.

Valley Strong Checking account indicates normal activity with the exception of a payment of \$2,032.20 to Shelby Pump for the removal and reinstallation of the pumping equipment in the Sand Canyon well to allow for video log.

Visa account indicates normal activity with exception of refund of \$72.96 from HughesNet for balance of service paid after cancellation of service.

CalCard account indicates normal activity with a charge of \$196.69 to Home Depot for the replacement of an air compressor at the Treatment Plant and \$350.00 to The Tire Store for 2 tires for service truck.

RCAC account indicates normal activity with a balance of \$49,263.98. Activity for September has not yet been recorded.

Budget versus Actual report indicates an income shortfall of \$12,504.61 for 1st quarter. Of this shortfall, about \$3,000 is attributed to lower operating revenues than forecast while about \$9,600 is from non-operating revenues, primarily taxes caused by a lack of reporting from Kern County and this should be corrected once transaction reports are available.

Expenses are mostly running slightly below forecast with exception of office supplies which are over budget by \$335 attributable to purchase of computer in 1st quarter. Building maintenance is over budget by \$893 which can be attributed to better record keeping as more labor costs are being captured in the categories expended and should be offset by a reduction in general labor.

Overall, Budget versus Actual report indicates total expenses under budget \$3,436 and total income under budget \$12,505. Income should recover once County tax information is available.

Staff does not currently recommend any budget adjustments.

Subject: Voluntary Rate Increase Refunds

In June of 2018, the District implemented a voluntary rate increase to boost cash flow and keep District solvent. Most customers participated by paying the surcharge with the understanding that they would get credit against the eventual rate increase expected once the Prop 218 process was completed. Refunds began in January of 2024 and all but 7 accounts have a zero balance.

Of the 7 accounts with a balance, 4 received a refund in excess of the account's VRI account balance. The over payments range from \$19.99 to \$49.37 for a total of \$141.34.

Two accounts have not had water service in excess of 1 year and have not received any refund. One account has a balance due of \$70.00 and the other has a balance due of \$770.00. It is not expected that either account will be active in the near future and both accounts are still in the name of the original customer.

The seventh account has a balance due of \$105.01 and changed customers several months ago. The original customer still has a balance due of \$84.93 and staff will credit the that amount from the VRI balance to bring the balance due to zero with the remaining \$20.18 being credited to the next water service bill to bring the VRI balance to zero.

Staff recommends that the two remaining accounts with a VRI balance receive a refund check sent to the last known address for the customer.

SYSTEM STATUS

October 2025

- Montclaire West Well continues to be the sole source for the entire system.
- Static water level has dropped to the level of the Montclaire East Well pump and the well is no longer able to produce water.
- For the month of October to date (10/17/25), Montclaire wells are averaging 9.6 hours per day, down from 13.03 in September, supplying an average of 14,420 gallons per day. Average pumping for September was 19,474 gallons per day.
- On October 17th, 2025, the Montclaire West Well static water level was 348 feet. On October 18th, 2024, static water level was 321 feet.
- 12-month running average monthly production as of October 1st was 553,616 gallons, an increase of 130,720 gallons from the same period in 2024.
- Monthly routine bacteriological sampling for April and May were completed in compliance with the combined system BSSP. All Routine samples were negative for coliform and e. coli. A source sample (collected directly from the well before disinfection), and follow-up sample, were positive for Total Coliform with a Most Probable Number of 1. The well was disinfected but current conditions do not allow for adequate dosing and flushing to properly disinfect the well but subsequent samples have been <1.
- Fe samples continue to indicate N/D levels post filtration. A Mn sample from August was 0.54 which is below allowable limits but indicates that effectiveness of filter may be diminishing. Also, with introduction of considerable chlorine into the well for disinfection, Fe and Mn may increase.
- Hackamore well was pumping at 9.5 gpm on September 29th, 2025.
